1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
2. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.

### I. Qualification/Eligibility Criteria

#### A. Experience & Past Performance:-

The Bidder should have supplied Folder Packing Material at least 6000 EA in any one of the last five years ending on 31.03.2022.

\* Bidders are required to submit the authorization/dealership certificate etc. directly from the manufactures for tendered items (if required). However, bidders have to qualify the PQC criteria (Except details of manufacturing). In such cases order will be placed on successful bidders.

#### 2. Capability - Equipment & Manufacturing Facilities:-

The Bidder must have an annual capacity to supply at least 6000 EA of Folder Packing Material.

#### 3. Financial Standing:

i)The average annual financial turnover of the bidder during the last three years, ending on 31.03.2022 should be at least Rs. 3,36,300/- as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/Cost Accountant in India.

ii) The bidder should not have suffered any financial loss for more than one year during the last three years ending on 31.03.2022.

iii)The net worth of the Bidder should not be negative on 31.03.2022 and should not have eroded by more than 30% in the last three years, ending on 31.03.2022.

**Note: 'Startups and Micro and Small Enterprises' are exempted from 'Average Annual Turnover Criteria' and Experience & Past Performance Criteria'.**

## II. Undertaking :

**III. Option Clause:** The Purchaser, I.G. Mint, Mumbai reserves the right to increase the ordered quantity by 25% at any time till the final delivery date of the contract by giving reasonable notice even though the quantity ordered initially is supplied in full before that the last date of delivery period.

**IV. Delivery Period** – a. 4 months from the date of Purchase Order for IGMM, Mumbai.

b. Item No.1-minimum order per theme is 1000 no's (for UNC-1000 no's & for Proof-1000 no's) and Item No.2- minimum 250 coins per day to be packed by the vendor.

**V. Payment Terms:** Payment will be made by IGM, Mumbai on monthly basis after Receipt and Acceptance of Good certified by competent authority and production of all required documents.

**VI. Warranty:** Warranty period is 12 months from the date of supply of material at IGM, Mumbai. The detailed warranty clause shall be as per General Conditions of Contract (GCC) Clause No.16.

**VII.** The Total Price quoted by the firm shall be considered for evaluation & to decide L1-bidder.

**VIII.** Evaluation of Bids: The Bid is split able. As per Clause No. 2.8.4 Procurement Preference for MSE point no. (vii) MSE quoting price within price band L1 + 15% may be awarded 25% of the total tendered value provided they agree to match the L1 price. In case of more than one such eligible MSE, 25% quantity is to be distributed proportionately among these bidders. Within this, a purchase preference of 4% is reserved for MSEs owned by SC/ ST entrepreneurs' and 3% is reserved for procurement from MSEs owned by women (if they participate in the tender process and match the L1 price, considering spirit of policy for enhancing the Govt. procurement from MSE.
