- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. ## I. Qualification/Eligibility Criteria

#### **Experience & Past Performance:-**

The bidder (manufacturer or principal of authorised representative hereinafter referred simply as 'The Bidder') shall be a manufacturer that has regularly for at least the last three years manufactured, supplied, erected, commissioned Video Wall with the same or higher specifications of at least 1 (One) No. in the last five years ending on 31.03.2022. At least one number of the product offered for supply should be in successful operation for at least one year on the date of bid opening. The Bidder may not be a manufacturer. However, such bidder has to submit the authorization/dealership certificate etc directly from the manufacturer for tendered items. Bidders have to qualify the PQC criteria (except details of manufacturing).

Note: 'Startups and Micro and Small Enterprises' are exempted from 'Experience and Pa st Performance Criteria'.

## 2. Capability - Equipment & Manufacturing Facilities:-

The Bidder must have an annual capacity to manufacture and supply 1 (one) No. Video Wall.

#### 3. Financial Standing:

i) The average annual financial turnover of the bidder during the last three years, ending on 31.03.20 22 should be at least Rs.13,09,564/- as per the annual report (audited balance sheet and profit & I oss account) of the relevant period, duly authenticated by a Chartered Accountant/Cost Accountant in India.

Note: 'Startups and Micro and Small Enterprises' are exempted from Annual Turnover'.

- ii) The bidder should not have suffered any financial loss for more than one year during the last three years ending on 31.03.2022.
- iii) The net worth of the Bidder should not be negative on 31.03.2022 and should not have eroded by more than 30% in the last three years, ending on 31.03.2022.

#### II. Undertaking:

Undertaking for acceptance of all the terms and conditions of the GeM Bid including Buyer Added Bid Specific Terms and conditions alongwith technical specification & scope of work without any deviation to be submitted duly sealed and signed.

- III. Delivery Period The total delivery period will be 16 weeks .The break-up of activities will be as und er:

Install and bring the system to operation complete with required installation of video wall panels, la ying of cables, interfacing, initial media contents preparation and pushing the contents, imparting t raining to IGMM officials for operation and maintenance etc. in all respect within 7 weeks from the date of supply of material not exceeding total delivery period of 16 weeks.

- IV. Payment Terms: 100% payment after successful Supply, Installation, Testing, Commissioning and FA T of Video Wall at IGMM.
- V. Warranty: The Bidder will have to give 36 months Warranty for the entire equipment and services covered in the scope & shall remain valid from the date of final acceptance certificate issued by IGMM and shall include repairing and replacing of defective parts of the system which includes Video Wall, Controller, Signage player, Work PC, required operational and maintenance support services at free of cost, which are essentially required to put the entire system in normal operation within 48 hours as and when problem arises and notified by IGMM failing which penalty will be imposed on Prograta basis i.e. the penalty will be calculated on the total cost of the project/1095 days (36 months warranty) and will be applicable on per day basis till the fault is resolved. For eg. if the cost of the project is Rs.28,00,00 0/- the penalty would be 2800000/1095 = Rs.2550/- (rounded off) per day. The detailed warranty clause shall be as per General Conditions of Contract (GCC) Clause No.16 (except Clause No.16.2)

- **VI**. Evaluation of Bids: The Bid is not splitable. The evaluation of the bids will be done on the total cost sub mitted by bidder. Since the job is not splitable MSE quoting price within price band of L1+15% may be awarded for full/complete supply of total tendered value to MSE considering the spirit of policy for enhancing the Govt. procurement from MSE.
- **VII. EMD:** EMD will be Rs.65,000/-, exempted for MSE firms.

- a) The FAT shall be conducted for 03 working days, from the date of commissioning of the system.
- b) The performance Test shall be carried out for all operational & functional checks by the successful bidde r for the entire system and its components supplied and installed by him. Also, firm will to show pushing c ontents from local work station.
- c) Design, Create and load only initial media contents as defined by IGMM's which shall include:" SPMCIL and IGMM full name, address, contact details, LOGO, including web sites, various products of IGMM to be d isplayed, pictorial symbols, pictorial stories, videos, animations, rates of products on sale, Art work etc.". A ny materials services required for On Load trials shall be borne by Bidder. The date of such test shall be finalized after completion of the entire works.
- d) During period of FAT, the firm will have to depute their Engineer for monitoring test results in 3 shifts for 24 hours i.e. 9.00 am to 9.00 am next day.
- e) Any short falls or any problems encountered during the FAT period and their after during the warranty p eriod, will have to be repaired and corrected immediately without any cost to IGMM.
