### **2. Capability - Equipment & Manufacturing Facilities:-**

The Bidder must have capability to provide the services of TPA (Third Party Administrator) for processing medical bills.

### **3. Financial Standing:**

iii) The net worth of the Bidder should not be negative on 31.03.2022 and should not have eroded by more than 30% in the last three years, ending on 31.03.2022.
