- 2. Capability-Equipment & manufacturing Facilities: The Bidder must have the capability of manufacturing and supplying precious metal blanks.
- 3. Financial Standing:

i. The average annual financial turnover of the bidder during the last three years, en ding on 31.03.2022 should be at least Rs.38,40,120/- as per the annual report (audited balan ce sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/Cost Accountant in India.

V. Special Conditions of Contract (SCC)

The following Special Conditions of Contract (SCC) will apply for this purchase. The corresponding clau ses of General Conditions of Contract (GCC) relating to the SCC stipulations have also been incorporat ed below. These Special Conditions will modify/substitute/supplement the corresponding (GCC) cl auses.

Whenever there is any conflict between the provision in the GCC and that in the SCC, the provision contained in the SCC shall prevail.

- 1. **<u>Raw Material</u>**: The QA Raw material required for making 30,000 pieces of QA blanks in the form of i ngots/scissile, rejected blanks etc, is to be lifted by the vendor from India Govt Mint, Kolkata (i.e. depending on the availability of QA Raw Material).
- 2. **Packing :** (GCC Clause No.8) Packing to be done for individual blanks basis to avoid any scratch du ring transit. The blanks should be packed in such a manner that they are not exposed to open atmosp here during the transportation. The packing provided by the supplier should be strong and durable en ough to withstand, without limitation, the entire journey during transit including transhipment (if any), rough handling, open storage etc without any damage deterioration etc. As and if necessary , the size weight and volumes of the packing cases shall also take into consideration, the remoteness of the final destination of the goods and availability or otherwise of transport and handling facilities to all points d uring transit upto final destination as per the contract.
- 3. Terms of Delivery : (GCC Clause No.10)
 - a) Initial 5000 blanks should be supplied within three weeks from the date receipt of raw material.
 - b) Remaining supply is to be done in lot of 5000 per two weeks from the date of receipt of raw material.c) Entire quantity blanks is to be delivered at IGM Mumbai.
- 4. **Warranty**: (GCC Clause No.16) Warranty shall remain valid for twelve months after goods or any portion thereof as the case may be, have been delivered to the final destination. Such warranty shall not apply for any blanks which may get damaged due to mishandling at the MINT and/or during the subseq uent stamping process. Upon receipt of such notice, the supplier shall verify with all reasonable speed repair or replace the defective goods or parts thereof, free of cost at India Govt. Mint, Mumbai from the date of receipt of material.
- 5. **Option Clause**: (GCC Clause No.19.3) The Purchaser, I.G. Mint, Mumbai reserves the right to increas e the ordered quantity by 25% at any time till the final delivery date of the contract by giving reasonabl e notice even though the quantity ordered initially is supplied in full before that the last date of delivery period.

6. Terms and Mode of Payments : (GCC Clause No.22.3, 22.4, 22.6) -

Payment will be made on completion of job as per delivery schedule mentioned above on each consign ment basis on receipt and acceptance of goods by purchaser and on production of the following docum ents by supplier i.e. Suppliers invoice indicating, inter alia description and specification of the goods as mentioned in Technical specifications, quantity, unit price, total value, packing list, Consignment Note, Manufacturers' Guarantee certificate and in house inspection Certificate , Inspection certificate issued by IGM, Mumbai's inspector and Test/Assay Certificates indicating physical dimensions and made com position for Quality Assurance.
