The following Special Instructions to Tenderers will apply for this purchase. In case of any conflict between the provisions in the GIT and that in the SIT, the provisions contained in the SIT shall prevail.

- 1. EMD: (GIT Clause 18.3) Rs.64,000/- exempted for MSE firms.
- 2. <u>Evaluation Method :</u> The Total Price quoted for item shall be considered for evaluation & to decid e L-1 bidder.

#### V. Special Conditions of Contract (SCC)

The following Special Conditions of Contract (SCC) will apply for this purchase. - i. The two VCB panels to be installed at two substations in IGMM premises are two different works, fir m will have to plan and implement the works one by one after completion of first work in totality. Shut do wn on both substations at a time may not be permitted.
- ii. The Contract Period is for 180 days from the date of order.
- iii. The firm will have to supply the material within 120 days from the date of Purchase Order and subseq uently install both PDBs within 60 days from the date of supply of material.

# 2. FINAL ACCEPTANCE TEST:-

a) After successful completion of installation and On Load trials, FAT shall be conducted for 03 wor king days/substation , from the date of commissioning of the system (excluding delivery period)

b) The performance Test shall be carried out for all operational & safety interlock checks by the su

ccessful bidder for the entire system and its components supplied and installed by him. The suc cessful bidder shall make at his own expense all arrangements, preparations, furnish testing eq uipment's and testing personnel and shall bear any expenses incurred for such tests. The date of such test shall be finalized after completion of the entire works on mutually agreed date.

- c) During this period of FAT the firm will have to depute their Engineer for monitoring and recordin g the test results for the systems working during day time from 9.00am to 5.00pm.
- d) Each VCB will be tested for the functioning and the firm will have to record and submit the test r esults.
- e) Any short falls or any problems encountered during the FAT period and their after during the wa rranty period, will have to be repaired and corrected immediately without any cost to IGMM and ensure no adverse impact on IGMM's Installation and BEST supply source.
- f) After successful completion of FAT, FAC will be issued by IGM-Mumbai.
- Terms and Mode of Payments : (GCC Clause No.22.3, 22.4, 22.6) -100% payment after issue of FAC and submission of all relevant documents

# 4. WARRANTY:-
