The average annual financial turnover of the bidder during last three years ending 31.03.2023, should be at least Rs.20,00,000/- as per annual report duly authenticated by the Chartered Accountant /Cost Accountant in India or equivalent in relevant countries.

Note: ‘Startups and Micro and Small Enterprises’ are exempted from ‘Average Annual Turnover Criteria’.

- b. Bidder Firm should not have suffered any financial loss for more than one financial year during the last three financial years ending 31.03.2023.

Bidder firm has to quote the price considering the total Estimated amount of Rs. 50 Lakhs and duly deducting the discount offered for all advertisements including art work/creative work on DAVP, so that the maximum discount offered by the bidder will stand L1 bidder on GeM.
