The bidder should be enlisted in either Central Public Works Department (CPWD) or Military Engineering Services (MEs) or any other Government/PSU/Autonomous bodies.

C. Financial Standing:

i) The average annual financial turnover of the bidder during the last three years, ending on 31.03.2023 should be at least Rs.468772/- as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/Cost Accountant in India.

ii) The bidder should not have suffered any financial loss for more than one year during the last three years ending on 31.03.2023.

iii) The net worth of the Bidder should not be negative on 31.03.2023 and should not have

eroded by more than 30% in the last three years, ending on 31.03.2023.

II. Undertaking :

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
