The Bidder must have an annual capacity to manufacture and supply at least 5800 Kg. of LDPE Film Roll.

#### 2. Financial Standing:

i) The bidder should not have suffered any financial loss for more than one year during the last three years ending on 31.03.2023.

ii) The net worth of the Bidder should not be negative on 31.03.2023 and should not have eroded by more than 30% in the last three years, ending on 31.03.2023.

#### II. Undertaking :

- i. Undertaking for acceptance of all the terms and conditions of the GeM Bid including Buyer Added Bid Specific Terms and conditions along with technical specification & scope of work without any deviation to be submitted duly sealed and signed.

**III. Option Clause:** The Purchaser, I.G.
