2) Terms and mode of payment

3) Option Clause:

India Government Mint Mumbai reserves the right to extend the contract at the same rate and ter ms & conditions for further 3 months and also increase the ordered quantity by 25% at any time til I the final delivery date of the contract by giving reasonable notice before the last date of contract period even though the quantity ordered initially is supplied in full before the last date of delivery p eriod.

4) Undertaking:

- i. Undertaking for acceptance of all the terms and conditions of the GeM Bid including Buyer Added Bid Specific Terms and conditions alongwith technical specification & scope of work without any de viation to be submitted duly sealed and signed.
- ii. Undertaking of declaration that the bidder is not blacklisted/debarred for dealing by Government of India in the past.
