The bidder should have experience of having successfully completed similar kind of services for the value at least Rs. 3,61,080/- , in any one of the last 5 years ending on 31.03.2023.

Note: Similar services means work related to Hallmarking of Gold.

2. Capability - Equipment & Manufacturing Facilities:-

The bidder must have capability to provide similar services.

3. Financial Standing:

i) The average annual financial turnover of the bidder during the last three years, ending on 31.03.2023 should be at least Rs. 3,61,080/- as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/Cost Accountant in India.

ii) The bidder should not have suffered any financial loss for more than one year during the last three years ending on 31.03.2023.

iii) The net worth of the Bidder should not be negative on 31.03.2023 and should not have eroded by more than 30% in the last three years, ending on 31.03.2023.

Note: 'Startups and Micro and Small Enterprises' are exempted from 'Average Annual Turnover Criteria' and Past Performance Criteria'.

II. Undertaking :

- i. Undertaking for acceptance of all the terms and conditions of the GeM Bid including Buyer Added Bid Specific Terms and conditions along with technical specification & scope of work without any deviation to be submitted duly sealed and signed.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
