The bidder should have experience of having successfully completed similar kind of services for the value at least Rs. 873227/- , in any one of the last 5 years ending on 31.03.2023.

##### **B. Capability - Equipment & Manufacturing Facilities:-**

The bidder must have capability to provide similar services.

##### **C. Financial Standing:**

i) The average annual financial turnover of the bidder during the last three years, ending on 31.03.2023 should be at least Rs. 873227/- as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/Cost Accountant in India.

ii) The bidder should not have suffered any financial loss for more than one year during the last three years ending on 31.03.2023.

iii) The net worth of the Bidder should not be negative on 31.03.2023 and should not have eroded by more than 30% in the last three years, ending on 31.03.2023.
