The bidder should quote uniform discount on maximum retail price printed. As strips/bottle/ unit packed o n percentage term in respect to all items of supplies to be made under contract. Liability to pay taxes/Vat/ Lavy/ Cess/ Octroi etc leviable under law would be that of supplier. The quote offer shall remain valid for th e entire duration of the contract.

The bidder firm shall quote the price considering the total amount of Rs. 10,00,000/- and duly deducting th e discount offered so that the maximum discount offered by the bidder will stand L1 bidder in GeM.

For Example bidder provides the 20% discount on Printed Price then the quoted price by the firm would be Rs. 8,00,000/- ( i..e. Rs. 10,00,000/- - 20% discount).

Based on the quoted price of the bidder with respect to estimated expenditure of Rs. 10,00,000/- discoun t offered on printed price will be calculated for making payment.
