#### 2. Capability - Equipment & Facilities:-

The Bidder firm must have capability to provide the Armed Security Guards services.

#### 3. Financial Standing:-

- i. The average annual financial turnover of the bidder firm during the last three years, ending on 31 .03.2023 should be at least Rs 17,66,029/- as per the annual report (audited balance sheet and p rofit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/Cost A ccountant in India.
- ii. The net worth of the Bidder Firm should not be negative on 31.03.2023 and also should not have eroded by more than 30% in the last three years, ending on 31.03.2023.

#### Note for Bidders:

- i. For MSE & start up (registered for the tendered items all financial criteria shall be exempted. However its capacity & capability may be verified (if necessary) by the IGM, Mumbai.
- ii. 'Doctrine of Substantial Compliance': The Pre-Qualification Bidding (PQB) and Pre-Qualification Criteria (PQC) are for shortlisting of sources who are competent to perform this contract to ensure best value for money from expenditure of Public Money.
