1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of guality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer. 3. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

4. Procurement under this bid is reserved for purchase from Micro and Small Enterprises having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal. If the bidder wants to avail themselves of the reservation benefit, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible to participate in this bid. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

Capability - Equipment & manufacturing Facilities:

The bidder must have an annual capacity to manufacture and supply at least 4000 nos. of Wooden Box.

i. Firm should quote for at least 25% of the total quantity.

#### II. Undertaking:

- i. Undertaking for acceptance of all the terms and conditions of the GeM Bid including Buyer Added Bid S pecific Terms and conditions without any deviation duly sealed & signed.
- ii. Undertaking of declaration that the bidder is not blacklisted/debarred for dealing by Government of Indi a duly sealed & signed.

**III. Parallel Contracts :** IGM, Mumbai reserves its right to conclude Parallel contracts, with more than one bidder. T he Parallel Contracts would be concluded as given below subject to alternate bidder matching the Prices with lowest bidder :

- i. In case of splitting it shall be done in the ratio of 60:40 respectively or spare supply capacity.
- ii. L1 shall be awarded atleast 60% mentioned above or his spare supply capacity whichever is I ower and
- iii. For the rest of the contract quantity, the lowest rate accepted will be counter offered to the L 2 party. On acceptance of the counteroffer, the order will be placed on L2 for 40% or the spare su pply capacity of the L2 bidder which is lower and so on to other tenderers. In case of non-accepta nce of the counteroffer by L2 party, similar offer shall be made to L3 and L4 and so on.
- iv. In case of only one eligible bidder, then quantity will be allocated on the basis of quoted quantit y or 100% of the tendered quantity, whichever is less.

**IV. Terms of Delivery:** The Contract period for 1 year is as follows:

i. After confirmation of theme and design the supplier has tosubmit the sample within 15 daysfor the approval. On approval of the sample 500no quantity to be supplied within 3 weeks, thereafter 500nos each week as per requirem ent for approved theme.

ii. If any of the supplied material is found having scratches, bends, printing problemgumming problem, or loosely fi t magnet etc. at later stage (while packing); the quantity found shall be rejected and has to be replaced by the sup plier.

- V. **Payment Terms:** Within 30 days after receipt and acceptanceof Goods and production of all required docum ents certified by competent authority for IGMM, Mumbai on prorata basis.
- VI. Warranty: Warranty period is 3 months from the date of last supply of material at IGM, Mumbai.
- VII. Evaluation Method: The Total Price quoted for item shall be considered for evaluation & to decide L-1 bid der item wise.
