Please refer to the above and your quotation for "Spare Part of ACSYS Laser Engraving Machine" In this connection kindly accept the following important terms & conditions as per our procurement rule:

- 1. Delivery period: 30 days from the date of PO
- 2. Scope of Work:

Item NO 01: Motor of fume extraction system:

- 1) To remove the fan and carry out necessary testing and diagnostic of problem of fan.
- Supply required parts and carry out necessary replacement of defective parts.
- 3) Install fan in the machine and take multiple trials.

Terms & Conditions:

1) IGMM has considered one part as defective and has been included in supply part on basis of the authorised service engineer of JUI during his visit to IGMM, however billing would be done on the term if machine runs with the spare part smoothly.



- 2) The ITC of repaired spare part, no lad and full load trials will be taken for five days.
- 3) The firm will have to provide the warranty for spares supplied and workmanship.
- 4) After placement of PO the firm will have to either depute their engineer within shortest period at IGMM on any working day to provide required services.
- 5) Inspection report will be initiated after extensive trials of fan for 10 days

Item NO 02: Installation and Testing charges.

3. Quotation Validity: 90 days

The quotation must be in the form furnished by procuring entity and should be in ink free corrections/erasures. In case there is any unavoidable correction it should be properly attested, otherwise the quotation will not be considered.

Quotation will be opened on due date at 3.00 p.m. at the indicated venue in presence of tenderer or their representatives who may wish to be present. Being PAC item, tender would be open as & when quotation is received by email/speed post.

4. GST: To be quoted.

Payment of GST is primarily the responsibility of the seller and will not be paid unless the percentage value is clearly mentioned in the quotation. If no indication regarding GST is recorded in the quotation, the GST will be

- 5. Payment Terms: Within 30 days after receipt and acceptance of Goods and Completion of services & production of all required documents certified by competent authority for IGMM, Mumbai.
- 6. Applicable law for the contract: As per government of India directive and SPMCIL procurement norms the applicable law for this contract shall be the laws prevailing in India.
- 7. Jurisdiction: As per government of India directive and SPMCIL procurement norms the Jurisdiction shall be
- 8. Manufacturer's name and country of origin of materials offered must be clearly specified. Please quote whether your organization is large scale industry or small-scale industry. If you have NSIC/SSI/MSI. certificate, please attach
- 9. Complete details and ISI specification if any must accompany the quotation. Make/Brand of the item shall be stated wherever applicable. If you have got any counter offer as suitable to the material required by us, the same
- 10. All supplies are subject to inspection and approval before acceptance. Manufacturer/Supplier Warranty Certificates and Manufacturer/Government Approved Lab Test Certificate shall be furnished along with the supply,
- 11. Force Majeure clause: In the event of any unforeseen event directly interfering with the supply of stores arising during the currency of the contract, such as war, hostilities, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts, or acts of God, the Contractor shall within a week from the commencement thereof, notify the same in writing to the Purchaser with reasonable evidence thereof. Unless otherwise directed by SPMCIL in writing, the supplier shall continue to perform its obligations under the contract as far as reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event. If the force majeure condition(s) mentioned above be in force for a period of



) days or more at any time, either party shall have the option to terminate the contract on expiry of 90 days of mmencement of such force majeure by giving 14 days# notice to the other party in writing. In case of such mination, no damages shall be claimed by either party against the other, save and except those which had curred under any other clause of this contract prior to such termination.

If the contractor fails to deliver the services or any installment thereof within the DP or at any time repudiates the tract before expiry of such period, the CFA without prejudice to the right of SPMCIL to recover damages for ach of contract may recover from the contractor as agreed L/D and not by wayof peralty a sum equivalent to 0.5% he prices of any stores which the contractor has lailed to deliver within the period agreed for delivery in the tract, for each week or part thereof during which the delivery of such stores may be in arrears where delivery reof is accepted after expiry of the aforesaid period. The total damages shall not exceed value of 10% of idelivered goods.

- 13. If the deliveries are not maintained and due to that account the Purchaser is forced to buy the material at your Risk and Cost from elsewhere, the loss or damage that may be sustained there by will be recovered from the defaulting supplier.
- 14. Please submit an undertaking stating that the price quoted in the referred quotation is lowest and your firm has not quoted price lower than this quoted rate to any organization in the last one year.


