- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. B. Experience & Past Performance:-_

The Bidder (manufacturer or principal of authorised representative - hereinafter referred simply as "The Bi dder") should have manufactured and supplied at least 20000 nos. of Folder Packing Material in any one y ear during the last five years ending on 31.03.2024.

C. Capability - Equipment & Manufacturing Facilities: -

The Bidder must have an annual capacity to supply at least at least20000 nos. of Folder Packing Material.

D. Financial Standing:

Note for Bidders:

- i. For MSE & start up (registered for the tendered items), Experience & Past performance and all financial criteria sh all be exempted. However, its capacity & capability may be verified (if necessary) by the IGM, Mumbai.
- **ii.** 'Doctrine of Substantial Compliance': The Pre-Qualification Bidding (PQB) and Pre-Qualification Criteria (PQC) are f or shortlisting of sources who are competent to perform this contract to ensure best value for money from expendit ure of Public Money. This process is neither intended to bestow any entitlement upon nor to create any rights or priv ileges for the Bidders, by way of overly hair-splitting or viciously legalistic interpretations of these criteria, disregarding the very rationale of the PQB and PQC. - **iii.** Along with all the necessary documents/ certificates required as per the tender conditions, the bidder should fur nish a brief write-up, backed with adequate data, explaining his available capacity (both technical and financial), for manufacture and supply of the required goods/ equipment, within the specified time of completion, after meeting all their current commitments.

II. Undertaking:

- **III. Parallel Contracts:** IGM, Mumbai reserves its right to conclude Parallel contracts, with more than one bidder. T he Parallel Contracts would be concluded as given below subject to alternate bidder matching the Prices with lowest bidder:

 - iii. For the rest of the contract quantity, the lowest rate accepted will be counter offered to the L2 party. On acceptance of the counteroffer, the order will be placed on L2 for 40% of quantity or the spare supply capacity of the L2 bidder, whichever is lower and so on to other tenderers. In cas e of non-acceptance of the counter offer by L2 party, similar offer shall be made to L3 and L4 and s o on.
 - iv. In case of only one eligible bidder, then quantity will be allocated on the basis of quoted quant ity or 100% of the tendered quantity, whichever is less.

- **IV. Option Clause:** The Purchaser reserves the right to increase/decrease the ordered quantity by up to 25% at a ny time, till final delivery date of the contract (or the extended delivery date of the contract), by giving reasona ble notice even though the quantity ordered initially has been supplied in full before the last date of Delivery Pe riod (or the extended delivery period of the contract).
- V. Terms of Delivery: 1 Year after placement of Gem order.
- 1. Minimum order quantity 500 nos. per theme.
- 2. After confirmation of theme and design, the supplier has to submit the sample within seven days. On approval of the sample required quantity to be supplied within 2 weeks to I.G.Mint, Mumbai.
- 3. Any further requirement of the same theme approved earlier shall supplied be in multiples of 100 (i.e., from mini mum 100 to maximum as per mint requirement in multiples of 100) and this has to be delivered within 2 weeks from the date of intimation.
- **VI. Payment Terms:** Within 30 days after receipt and acceptance of Goods and production of all required docume nts certified by competent authority for IGMM, Mumbaion prorata basis.
- VII. Warranty: Warranty period is 3 months from the date of last supply of material at IGM, Mumbai.
- **VIII. Evaluation Method:** The Total Price quoted for all items shall be considered for evaluation & to decide L-1 bidd er.
- **IX. Performance Security Deposit**: 5% of order value.
