1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. 4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

ii. 'Doctrine of Substantial Compliance': The Pre-Qualification Bidding (PQB) and Pre-Qualification Criteria (PQC) are f or shortlisting of sources who are competent to perform this contract to ensure best value for money from expendit ure of Public Money. II. Undertaking:

III. Parallel Contracts: IGM, Mumbai reserves its right to conclude Parallel contracts, with more than one bidder. T he Parallel Contracts would be concluded as given below subject to alternate bidder matching the Prices with lowest bidder:

i. In case of splitting, it shall be done in the ratio of 60:40 respectively or spare supply ca pacity.

ii. L1 shall be awarded at least 60% of total quantity or his spare supply capacity whicheve r is lower and

iii. For the rest of the contract quantity, the lowest rate accepted will be counter offered to the L2 party. On acceptance of the counteroffer, the order will be placed on L2 for 40% of quantity or the spare supply capacity of the L2 bidder, whichever is lower and so on to other tenderers. In c ase of non-acceptance of the counter offer by L2 party, similar offer shall be made to L3 and L4 an d so on.

iv. In case of only one eligible bidder, then quantity will be allocated on the basis of quoted quantity or 100% of the tendered quantity, whichever is less.

- **IV. Option Clause:** The Purchaser reserves the right to increase/decrease the ordered quantity by up to 25% at a ny time, till final delivery date of the contract (or the extended delivery date of the contract), by giving reasona ble notice even though the quantity ordered initially has been supplied in full before the last date of Delivery Pe riod (or the extended delivery period of the contract).
- V. Terms of Delivery & Delivery Period: a. Contract period is for 1 Year after placement of Gem order as & whe n required basis.

b. Minimum order quantity 750 nos for proof and 750nos UNC variety Per theme.

c. After confirmation of theme and design, the supplier has to submit the sample within seven days. On approval of the sample required quantity to be supplied within 3 weeks to I.G.Mint. Mumbai.

VI. Payment Terms: Within 30 days after receipt and acceptance of Goods and production of all required docume nts certified by competent authority for IGMM, Mumbai on prorata basis.

VII. Warranty: Warranty period is 3 months from the date of last supply of material at IGM, Mumbai.

VIII. Evaluation Method: The Total Price quoted for all items shall be considered for evaluation & to decide L-1 bidd er.

IX. Performance Security Deposit: 5% of order value.

Note: Before issue of order on GeM on successful firm 'Notification of Award of contract' will be issued on firm duly requesting to deposit the performance security within 15 days (as per GeM).
