Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in

This regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

#### I. Delivery Period -

4. If any additional frames of same theme are required by IGMM, max. 40 nos. of frames

per week are to be supplied by the vendor.

## II. Undertaking:

- i. Undertaking for acceptance of all the terms and conditions of the GeM Bid including Buyer Added Bid Specific Terms and conditions without any deviation to be submitted duly sealed and signed.
- ii. Undertaking of declaration that the bidder is not blacklisted/debarred for dealing by Government of India duly sealed and signed

## III. Payment Terms:

Within 30 days on receipt and acceptance of goods and production of all required documents certified by competent authority for IGM, Mumbai on prorata basis.

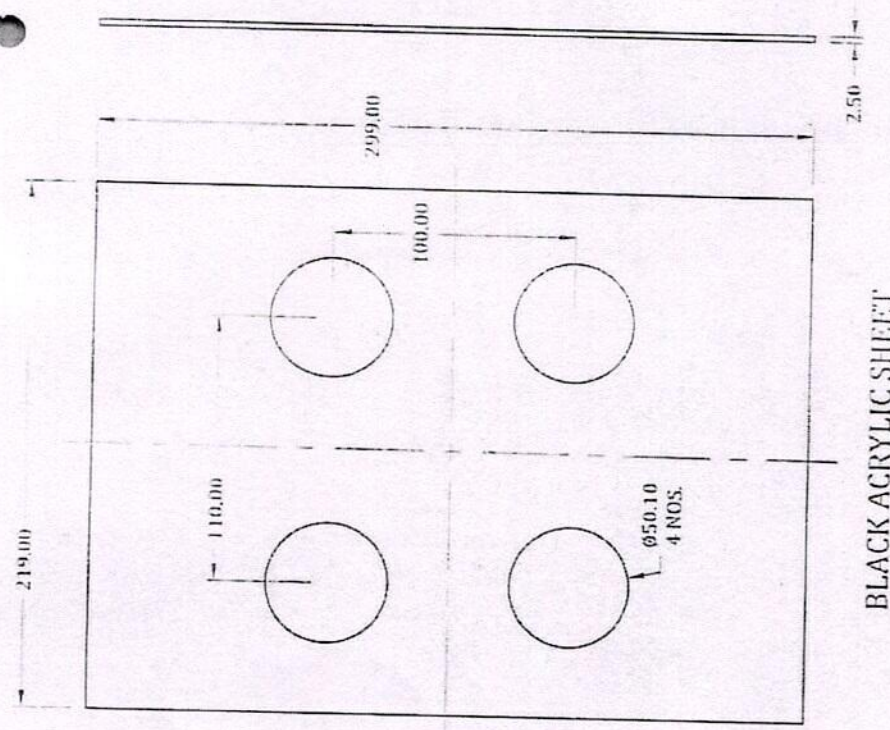
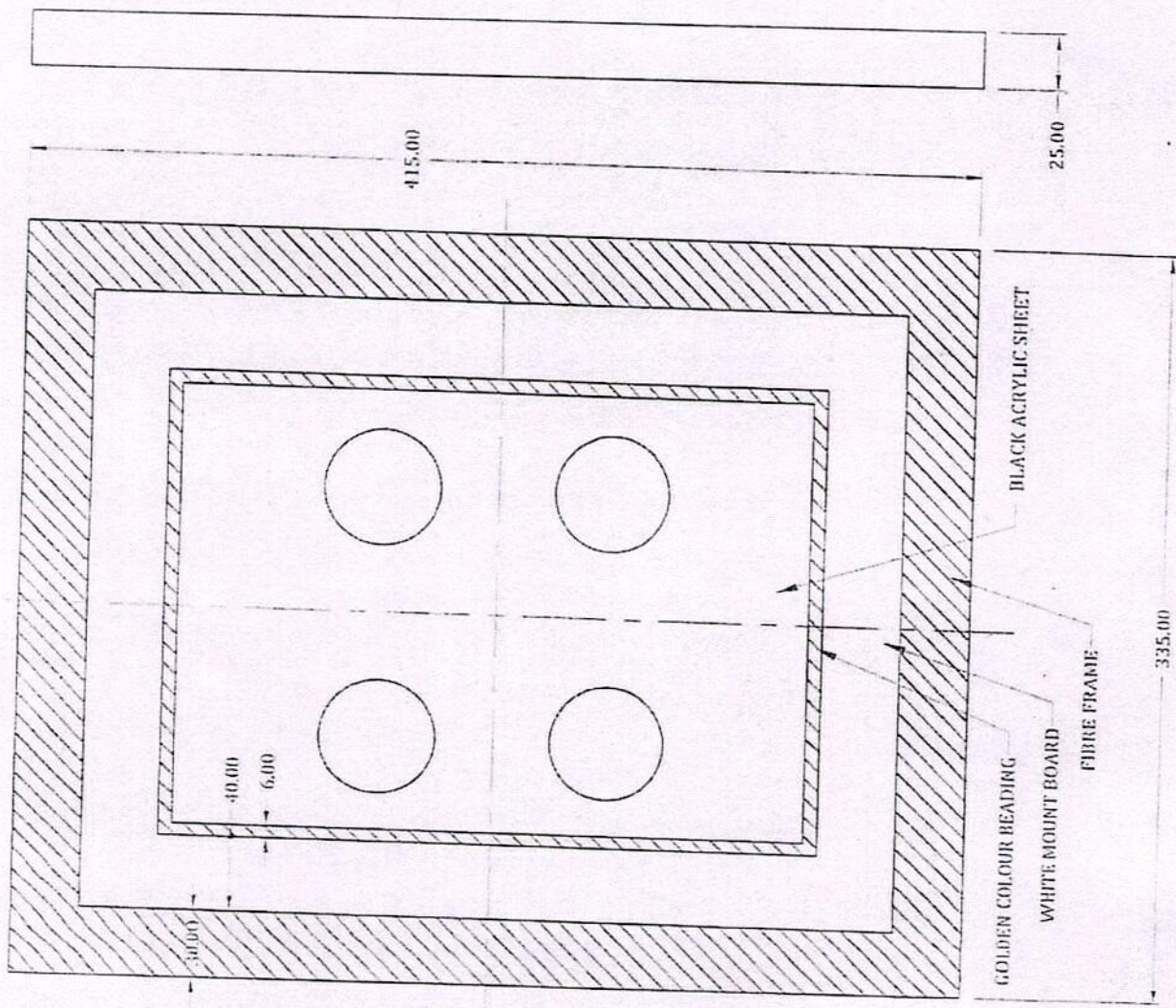
1. Four coin inauguration frame as per drawing no.DDN-12.
2. Black acrylic sheet shall have 04 nos. of laser cut holes as per the drawing and shall have screen printed text in Hindi & English.
3. Velvet cloth should be pasted on the back side of the frame.
4. Frame should be provided with wall mounting hooks and supporting stand.

Note:

1. Inauguration frames are required for various commemorative coin themes.
2. Minimum quantity per theme is 02 nos.
3. Theme details for screen printing on black acrylic sheet will be given by IGMM.
4. Sample Inauguration frame is available at IGM, Mumbai.
5. Vendor shall replace defective material free of cost.
6. Option clause is applicable on this contract.

Delivery:
